SECTION 4: First aid measures

4.1 Description of first aid measures

7.1 Precautions for safe handling

Precautions for safe handling : Wash Hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapour.

Storage conditions : Keep only in the original container in a cool ventilated place away from direct (sun)light. Keep container closed when not in use. Do not freeze. Do not use after expiry date. The product can be safely used up to 7 days after opening the container when sterile conditions are maintained and the products are stored at 2-8°C. Content cannot be resterilized after opening.
